

**Thorntons 50th Anniversary 'Free Fuel for a Year' Sweepstakes
Official Rules**

NO PURCHASE OR PAYMENT NECESSARY TO ENTER. THE ODDS OF WINNING A PRIZE ARE SUBJECT TO THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED.

BY ENTERING THE SWEEPSTAKES, EACH ENTRANT (OR ENTRANT'S PARENT/LEGAL GUARDIAN, IF ENTRANT IS DEEMED A MINOR IN THE STATE OF HIS/HER RESIDENCE) AGREES TO THESE OFFICIAL RULES.

- 1. Eligibility** - The Thorntons 50th Anniversary Free Fuel For a Year Sweepstakes (the "Sweepstakes") is open only to legal residents of FL, IL, IN, KY, OH and TN who are eighteen (18) years or older and have a Refreshing Rewards® card at the time of entry. - 2. When to Enter** - The Sweepstakes begins on May 5, 2021 at 12:00:00 AM Eastern Time ("ET") and ends on September 7, 2021 at 11:59:59 PM ET (the "Sweepstakes Entry Period").

The Sweepstakes consists of one element: (1) the grand prize sweepstakes portion ("Grand Prize Pool").

The Grand Prize Pool will be one entry pool. When an entrant clicks to load the entry from the Thorntons Refreshing Rewards App, he/she will automatically receive entry into the Grand Prize Pool. - 3. How to Enter** - During the Sweepstakes Period, when an eligible participant entrant clicks to load the entry from the Thorntons Refreshing Rewards App, he/she will automatically receive an entry into the Grand Prize Pool.

5. **Winner Selection** - There will be a total of two hundred (200) Grand Prize winners. On or about June 3, 2021, the first fifty (50) Grand Prize winners will be selected via a random drawing to be held by Administrator, from among all eligible Grand Prize Pool Entries received. On or about July 8, 2021, an additional fifty (50) Grand Prize winners will be selected via a random drawing to be held by Administrator, from among all eligible Grand Prize Pool Entries received. On or about August 5, 2021, an additional fifty (50) Grand Prize winners will be selected via a random drawing to be held by Administrator, from among all eligible Grand Prize Pool Entries received. On or about September 8, 2021, the final fifty (50) Grand Prize winners will be selected via a random drawing to be held by Administrator, from among all eligible Grand Prize Pool Entries received. Winners are ineligible to win more than once and will be excluded from subsequent prize pool drawings during this Sweepstakes.

THE POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY ADMINISTRATOR AND ADMINISTRATOR'S AND SPONSOR'S DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE SWEEPSTAKES.

Sponsor makes no warranties, and hereby disclaims any and all warranties, express or implied, concerning any Prize furnished in connection with the Sweepstakes.

7. **Participation Conditions/Release/Consent to use Likeness:** By participating, each entrant (or entrant's parent/legal guardian's, if entrant is deemed a minor in the state of his/her residence) agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Sponsor which are binding and final in all matters relating to this Sweepstakes; (b) release and hold harmless the Sponsor/Administrator from and against any and all claims, expenses, and liability, including, but not limited to, negligence and damages of any kind to persons and property, including, but not limited to, invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's participation in this Sweepstakes, and acceptance or use or misuse of prize; (c) release Facebook, Inc. from any and all liability associated or in connection with Thorntons LLC's Sweepstakes promotion, and each Entrant further understands and agrees that this Sweepstakes is in no way sponsored, endorsed, administered by, or associated in any way with Facebook, Inc. and that any and all information provided by Entrant is provided exclusively to Thorntons LLC. and not Facebook, Inc. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the participation process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Either party may enforce a final arbitration award in any court of competent jurisdiction in Kentucky, including an award of costs, fees and expenses incurred in enforcing the award. Notwithstanding the foregoing, Sweepstakes Entities shall be entitled to seek injunctive relief (unless otherwise precluded by any other provision of these Official Rules) in the state and federal courts of Kentucky. Any dispute or portion thereof, or any claim for a particular form of relief (not otherwise precluded by any other provision of these Official Rules), that may not be arbitrated pursuant to applicable state or federal law may be heard only in a court of competent jurisdiction in Kentucky; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. **SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Kentucky, without giving effect to any choice of law or conflict of law rules (whether of the State of Kentucky or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Kentucky.
